Representative Work for Plaintiffs

Representative Work for Defendants

Preliminary enjoined defendant's communications with his client's customers. The defendant threatened the client and its customers with a patent infringement action. Mr. Anderson filed a complaint for declaratory judgment of non-infringment and successfully obtained a preliminary injunction against the defendant. The parties settled the dispute on terms favorable to the client.

Obtained summary judgment for client on contract claims. The client asked Mr. Anderson to assume responsibility for the case after a former counsel's motion for partial summary judgment was denied. Summary judgment was successfully obtained for all substantive claims against the client resulting in a favorable settlement and dismissal of plaintiff's case.

Successfully obtained several dismissals of claims on jurisdictional grounds.

Successfully argued in multiple Markman hearings for patent claim construction and obtained summary judgment based on those rulings.

Successfully defeated plaintiff's Motion for Preliminary Injunction with a Motion for Summary Judgment. Plaintiff alleged the client, a medical device manufacturer, infringer plaintiff's trademark and trade dress rights and that the client falsely advertised its medical devices. Mr. Anderson engineered and successfully executed the strategy to transfer the case from plaintiff's home jurisdiction in Georgia to the 9th Circuit where the case law was more favorable to the client's position. Plaintiff appealed the court's ruling in the client's favor. Mr. Anderson then successfully negotiated the final settlement.

Successfully negotiated favorable settlement and dismissal with prejudice of copyright infringement claims within weeks of claims being filed.

Successfully defended and resolved claims for Trade Secret Misappropriation.
